1. Introduction

This report is about the analysis of financial performance of Chinese listed pesticide enterprises in 2016. In 2016, China's pesticide market remained flat on the whole. Pesticide producers, especially those of raw materials and intermediates, have been facing increasing production costs, due to continuously strengthened environmental regulations by the Chinese government. Furthermore, influenced by the slack domestic & overseas demand and restrictions/bans on high-toxicity pesticides, depressed prices of pesticides and even reduced profitability could be found in the whole pesticide industry. As representatives of pesticide companies in China, domestic listed pesticide enterprises are supposed to be the guides for the development of the whole industry. In this issue, annual reports of 21 main domestic listed enterprises involved in pesticides and/or pesticide intermediates were summarized and analysed.

2. Approach for this report

The report is drafted by diverse methods as follows:

- Desk research

The sources of desk research are various, including published magazines, journals, government websites and statistics, industrial statistics, association seminars as well as information from the Internet. A lot of work has gone into the compilation and analysis of the obtained information.

- Internet

CCM visited government websites and contacted with players in the domestic agrochemical industry through B2B websites and software as well as obtained registration information on the internet.

- Data processing and presentation

The data collected and compiled are sourced from:

- CCM's database
- Published articles in periodicals, magazines, journals and third-party databases
- Statistics from governments and international institutes
- Telephone interviews with domestic producers, joint ventures, service suppliers and governments
- Third-party data providers
- Comments from industrial experts
- Professional databases from other sources
- Information from the internet



The data from various sources have been combined and cross-checked to make this report as precise and scientific as possible. Throughout the process, a series of internal discussions were held in order to analyse the data and draw the conclusions.

3. Executive summary

In 2016, China's pesticide market remained flat on the whole. Pesticide producers, especially those of raw materials and intermediates, have been facing increasing production costs, due to continuously strengthened environmental regulations by the Chinese government. Furthermore, influenced by the slack domestic & overseas demand and restrictions/bans on high-toxicity pesticides, depressed prices of pesticides and even reduced profitability could be found in the whole pesticide industry.

As representatives of pesticide companies in China, domestic listed pesticide enterprises are supposed to be the guides for the development of the whole industry. In this issue, annual reports of XXX main domestic listed enterprises involved in pesticides and/or pesticide intermediates were summarized and analysed.

Except Zhejiang Shenghua Biok Biology Co., Ltd., all other XXX listed enterprises achieved the most revenue from their pesticide business. As for Zhejiang Shenghua Biok Biology Co., Ltd., its revenue from pesticide business kept declining in 2013–2016.

2 Analysis of 21 Chinese listed pesticide enterprises

2.1 Nanjing Red Sun Co., Ltd.

In 2016, Nanjing Red Sun Co., Ltd. (Nanjing Red Sun, stock code: 000525) had a disappointing performance. To be more specific, it gained a revenue of USDXXX million, decreasing significantly by XXX% year on year. Thereinto, the revenue of its pesticide business in 2016 decreased to USDXXX million, accounting for XXX% of the total, down by XXX% compared with that in 2015. What's worse, the company suffered a decrease in its net profit, which was USDXXX million, down by XXX% year on year.

It is worth noting that Nanjing Red Sun suffered year-on-year decreases in net profit in both 2015 and 2016, not only because of the industry downturn, but also because that Nanjing Red Sun spanned off its fertilizer business.
