This report provides an overview of the new registrations of pesticide technical in China in 2017, and introduces the new registrations of herbicide technical, insecticide technical and fungicide technical in detail.

The report is drafted by diverse methods as follows:

- Desk research

The sources of desk research are various, including published magazines, journals, government websites and statistics, industrial statistics, association seminars as well as information from the Internet. A lot of work has gone into the compilation and analysis of the obtained information.

- Internet

CCM visited government websites and contacted with players in the domestic agrochemical industry through B2B websites and software.

- Data processing and presentation

The data collected and compiled are sourced from:

- CCM's database
- Published articles in periodicals, magazines, journals and third-party databases
- Statistics from governments and international institutes
- Telephone interviews with domestic producers, joint ventures, service suppliers and governments
- Third-party data providers
- Comments from industrial experts
- Professional databases from other sources
- Information from the internet

The data from various sources have been combined and cross-checked to make this report as precise and scientific as possible. Throughout the process, a series of internal discussions were held in order to analyse the data and draw the conclusions.



In 2017, there had been xxx new registrations and xxx renewed registrations of pesticide technical in China, accounting for xxx % and xxx % of the total xxx registrations, respectively.

Implemented on 1 June, 2017 and 1 Aug., 2017 respectively, the *New Regulations on Pesticide Administration* and the amended *Measures on Administration of Pesticide Registration* would certainly influence the registration of pesticide technical in China in 2017.

In the past, the new registrations of pesticide technical had four major characteristics. Firstly, the number of full registrations was way beyond that of temporary registrations. Secondly, the number of new registrations of TC was much larger than that of TK. Thirdly, the new registrations of pesticide technical for agricultural use far outnumbered that for sanitary use. Fourthly, the number of new registrations of herbicide technical ranked first among all the categories of registered pesticide technical. Did these situations continued in 2017?

This report not only shows an overview of the new registrations of pesticide technical in China in 2017, but also introduces the new registrations of herbicide technical, insecticide technical and fungicide technical in detail.

Note: Unless otherwise mentioned, pesticide technical in this report refers to technical material (TC) and technical concentrate (TK).
