4) Data processing and presentation

- Statistics from governments and international institutes
- Telephone interviews with domestic producers, joint ventures, service suppliers and government agencies
- Third-party data providers
- Customs statistics



- Comments from industrial experts
- Information from the Internet

The data is combined and cross-checked to ensure that this report is as accurate and methodologically sound as possible. Throughout the process, a series of discussions are held within CCM to systematically analyse the data and draw appropriate conclusions.



3. Executive summary

There are two main varieties of fluor polymer in China, including fluor resin and fluor rubber. In H1 2020, the capacity of fluor polymer was more than XXX t/a in China, and the output of fluor polymer was about XXX tonnes.

According to the "13th Five-Year Plan" for development of China's fluorine chemical industry, fluor polymer is the main development direction to improve industrial concentration and the proportion of medium- and high-end products. Fluor resin focuses on the development of special and modified PTFE, high-quality functional PVDF, high-speed processing cable FEP and other special fluorine materials. Fluor rubber focuses on the development of high-performance 246 fluor rubber, fluorine-containing polyurethane and other rubber materials. 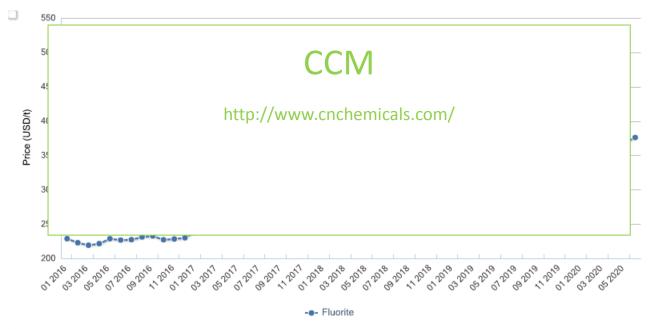

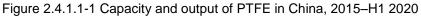

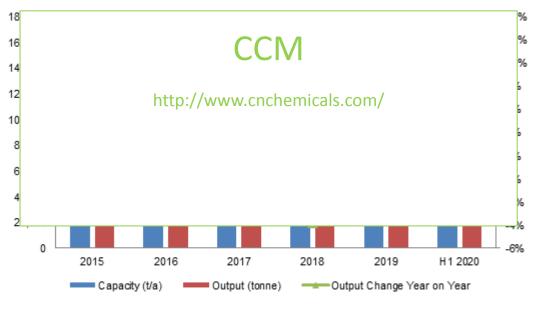
